- Pursuant to Customs Law no. 04/NA, dated 20 December 2011 and Customs Law (Amended some articles) no. 57/NA, dated 24 December 2014;
- Pursuant to the Customs Instruction no. 06001/CD, dated 12 September 2017 on the managing the use of commodity prices databases in the ASYCUDA System;
- Pursuant to the Notification on the Identification of Tariff Specific Code (TSC) for Valuation Module in ASYCUDA System, no 00785/CD, dated 13 February 2018.

Department of Customs kindly inform on the identification of tariff specific code (TSC) for valuation module in ASYCUDA System, no 00785/CD, dated 13 February 2018, has been implemented as a pilot project, it is shown that some information was missing such as exporting country, if producing and exporting countries is the same destination that used the same of TSC as specified in this table below, in case there is not the same that must be determined mew of TSC into the system. Therefore, the information has been added to fully comply on using Tariff Specific Code-TSC as following:

- 3. Import declaration as goods has mentioned above, customs broker must put in HS Code of 10 digits into Box 33 in the left-hand side and TSC of 4 digits into Box 33 in the righthand side of the customs declaration form in detailed.
- 4. The case of import the new model of vehicle which is TSC not exist yet. The importer has to requests documents such as proof documents with real prices certification to customs department such as invoice, purchasing agreement, certificate of origin, payment through the banking system and others regarding customs department as a consideration in terms of creating prices and TSC database for reference on the customs declaration.
- 5. The implementation of customs declaration in detail has to follow the Customs Department of Instruction on Electronic Customs Declaration N0. 00097/CD, dated 6 January 2017.
- 6. Customs Border Checkpoints nationwide are responsible for inspecting and using of TSC in the customs declaration correctly and uniformly. This additional notification to replaces the Notification on the Identification of Tariff Specific Code (TSC) for Valuation Module in ASYCUDA System, no 00785/CD, dated 13 February 2018.

Therefore, this must be informed and strictly implemented.
